All applications may be turned in beginning 9/20/08. Generally Juniors and Sophomores have lower priority.

You must turn in a COPY of your vehicle registration and driver's license (or permit and PL-90) with application. Return these forms to Dean Snyder or Dean Patterson. All parking passes will be issued beginning 9/30/08 and will become effective immediately. You may pay and pick it up at PHS after September 30, 2008 with Officer Wiggins on Monday-Wednesday. All vehicles parking at PHS must have a valid permit displayed before October 16th, 2008!

Discipline Process

Violation of a Parking Regulation will result in a discipline referral and a phone call to parent/guardian indicating a warning/consequence has been issued and recorded. Student Conduct Referral of any kind may result in immediate permit revocation as a discipline consequence. Violation of parking regulations may result in removal of car from the school grounds.

Be sure to read the rules carefully!

Regulations: Seat belts must be worn by all occupants, at all times on school property or school events!

- I will be on time to all of my classes: Drivers need to arrive before school. (Tardy policy applies)
- During the school day, I am not to go to my car or allow others to go to my car (unless I have prior administrative approval).
- I will not leave school grounds for any reason during the school day without administrative approval.
- I will not transport other students to and from school without parental/administrative approval.
- I am not to drive recklessly or over 15 miles per hour on school grounds.
- I understand that all school rules apply when driving to or from school and while on school grounds. Refer to Student Rights and Responsibilities Handbook.
- I am not to give or loan my parking permit to another student.
- I have completed the application to include a copy of my driver's license and vehicle registration.
- I will lock my car while it is parked on school grounds. The school is not responsible for damage/theft.
- Upon arriving or leaving school, I am not to sit in my car or loiter around my car.
- I must place my permit only on the car registered on my application.
- I will display my permit on the vehicle at all times while on school property.
- I will turn down all radio/stereo equipment while on school property.
- I will only park in designated student parking lot spaces; not in visitor, faculty, or staff parking areas.
- If my car is towed for being illegally parked, or for other reasons, I will be responsible for the towing charges.
- In case of an accident in the parking lot or on school grounds, I am expected to exchange insurance and license information with the other party. Police or School Resource Officer may be summoned to the scene.
- **I realize that driving to school is a privilege, not a right. This privilege may be suspended or revoked if:**
 1. **the rules above are not obeyed,**
 2. **I am removed from any approved program, and/or**
 3. **my behavior at school including behavior in the classroom (e.g., disciplinary referrals, cuts, tardiness, grades) indicates that I am not responsible enough to deserve this privilege**
- I agree to all terms and conditions outlined in the application and have signed the signature form.
- **I understand that in order to maintain reasonable control of the educational atmosphere, the PHS administration reserves the right to search and seize any property within the vehicle, which violates state law, school regulation, or may be harmful to any person.**
